- Papers submitted on or before the timeline shall only be considered.

- All abstracts and final manuscripts shall be submitted in MS Word format (DOC or DOCX).

### ABSTRACT SUBMISSION

- The author(s) shall submit an abstract with a word limit of 300 words along with 5 keywords.
- Acceptance of abstracts shall be communicated separately. The abstract must be accompanied by a cover page stating the following:
  - 1.Sub-theme of the paper.
  - 2. Title of the Paper.
  - 3. Name of the authors.
  - 4. E-mail address of the authors

- 4. The main text should be in Times New Roman with font size 12 and 1.5 line spacing.
- 5. The footnotes should be in Times New Roman, font size 10, with single line spacing.
- 6. One-inch margins on all sides should be maintained.
- 7. Citation style: Harvard's Bluebook Legal Citation System, 20th Edition.
- 8. All correspondence must be sent to *conference.solindore@nmims.edu*
- 9. The full paper must be sent to conference.solindore@nmims.edu with subject line "**Paper for SOL International Conference**" on or before January 05, 2024.
